

ADULT RELEASE FORM

We, the undersigned hereby request permission (1) to enter the restricted area (2) to participate as a contestant, assistant, official or otherwise (3) to compete for money, prizes, recognition or reward and/or (4) participate as a spectator.

In consideration of “permissive entry” into the restricted areas, which is the area from which admission to the general public is restricted, which includes, but is not limited to the arena, pit areas, tracks, adjacent walkways, concessions and other appurtenances, I undersigned, my personal representatives, heirs, next of kin, spouses and assigns do hereby:

1. Release, discharge, and covenant not to sue Grant County Fair, Inc. or its officers (individually or collectively), the Grant County Fair Board, any member of the Grant County Fair Board, contractors, sponsors, volunteers, arena/venue operators or owners and each of them, their officers agents and employees all hereafter collectively referred to as (Releasees) from any and all claims and liability arising out of strict liability or ordinary negligence of Releasees or any other participant which causes the undersigned injury, death, damages, or property damage. I, the undersigned, jointly, severally and in common, covenant to hold Releasees from any claim, judgment or expenses that may incur arising out of my activities or presence in the restricted area.

2. Understand that entry into the restricted area and/or participation in the events contains danger and risks of injury or death that conditions of the arena/venue change from time to time and may become more hazardous, that there are inherent dangers in motorcycle/ATV events which I appreciate and voluntarily assume because I chose to do so. Each of the undersigned has observed events of this type and that I seek to participate in. I further understand that the arena/venue surface, access ways or lack of thereof, lighting or lack thereof, and conditions all change and pose a danger. I further understand that other contestants and participants pose a danger, but nevertheless I voluntarily elect to accept and assume all risks connected with the entry into restricted areas and/or participate in any motorcycle/ATV events.

3. I agree that this agreement shall apply to any incident, injury and accidental death occurring on the date below and for a period of one (1) year thereafter. All subsequent agreement and release documents signed by any of the undersigned shall amplify and shall in no way limit the provisions of this document.

4. I, the undersigned, agree to indemnify the Releasees and each of them from any loss, liability, damage or cost they may incur due to the presence or participation in the described activities, whether caused by the negligence of the Releasees or otherwise.

WE HAVE READ THIS DOCUMENT, WE UNDERSTAND IT IS A RELEASE OF ALL CLAIMS, WE APPRECIATE AND ASSUME ALL RISKS INHERENT IN MOTORCYCLE/ATV EVENTS.
